- 1. Properly filled in Forms.
- 2. Money Receipts with seal and signature (Original)
- 3. Detailed Bill for IPD/OPD with break-up of Bill (Original)
- 4. Bill Summary for IPD/OPD treatment sequentially (Original).
- 5. System generated medicine bill with GST Number (Original)
- 6. Attested (By the Principal/TIC) Income Declaration (Annexure-V) of dependent parents (both)
- 7. Copy of Discharge Summary/Case Summary in case of Death (with Death Certificate)
- 8. Copy of all Prescriptions.
- 9. Copy of all Investigation Reports (if claimed) from empanelled Hospital/Diagnostic Centre.
- 10. Detailed List with break-up of Miscellaneous Items.
- 11. Properly filled Annexure-II for IPD (if non empanelled Hospital)
- 12. Copy of WBHS Enrolment Certificate
- 13. Audiometry Report in case of buying Hearing Aid (original)
- 14. Voucher /Tax Invoice of Implants used (Original)
- 15. Letter with valid reasons when the submission has been made after 6 months (vide order no 67-F (MED)WB dated 25/06/2020)

It is also requested that the claimant should submit duly completed application form along with all requisite supporting documents as mentioned above to the office of the Principal. Upon receipt, the college authority is kindly requested to verify and forward the complete set of documents to the Directorate within ten (10) working days both online and offline at a time, to enable timely processing and necessary administrative action, as far as practicable.
